Operation School Bell began in Tucson in 1994 with 335 children, a number that has grown to more than 3,600 children in 2010-2011. Over 40,000 children have participated in this program since inception. Children receive new outfits (three tee-shirts or blouses, two jeans or shorts; or two school uniforms) a pair of shoes, a jacket, six pairs of underwear, six pairs of socks, a backpack, an age and grade appropriate book, school supply kit and a grooming kit (notebook, ruler, pencils, eraser, crayons/markers, scissors, shampoo, toothpaste, soap and a comb). The children served by Operation School Bell are from 33 Title 1 schools within 5 area school districts. The children, who come from families with extreme need, are selected by administrators, teachers and counselors at the respective schools. The majority of these K-5 children are involved in the Title 1 Free Lunch Program as defined by federal government guidelines and most of their parents are among the "working poor" of Tucson. In addition, Arizona's Children Association, Amity Foundation and Southwest Family Education Resource Center refer children to Operation School Bell.

Project Teddy Bear is a program provided by Professional Association of Women's Services. P.A.W.S., an auxiliary of Assistance League of Tucson, was founded to provide volunteer opportunities to women in the workplace. This auxiliary focuses on helping children in crisis. More than 20,000 teddy bears have been distributed to children through approximately 30 law enforcement, social service agencies and hospitals in Southern Arizona. These small, stuffed, cuddly creatures possess the super hero power to soothe the cries of a terrified child being removed lying critically ill in a hospital nursery and even help ignite a lost memory of security in a teenager abandoned and alone.

Their program, "Assisteens Helping Tucson Teens", helps empower middle school students by providing needed supplies in the areas of art, music and physical education. The funds for this program are raised at an annual fashion show, which these young women plan and participate in.

Assault Survivor Kits, partnering with a center for sexual assault, provides simple clothing and toiletry items through local hospitals to victims of rape or assault whose personal clothing is often retained by the police for forensic evidence.

New sweat pants, socks, t-shirts, sweatshirts, underwear, flip-flops and toiletry items were provided to 168 men, women and children with the hope the survivor will leave the hospital or trauma center with dignity.

Education program run by the chapter's P.A.W.S. auxiliary. Books and education supplies are furnished for a Tucson area school.
